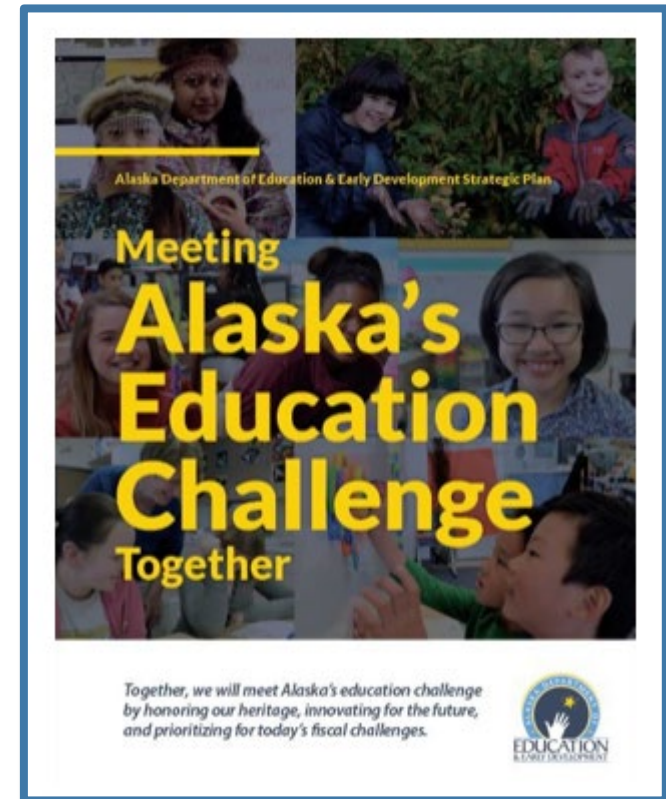

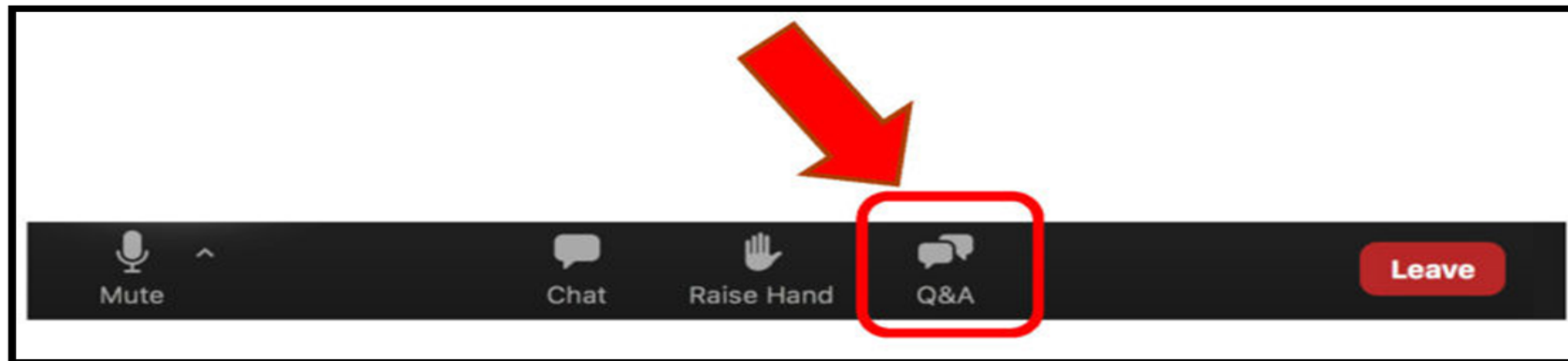

House Bill 114

Virtual education consortium

The department shall, in cooperation with school districts, establish a virtual education consortium for the purpose of making virtual education and professional development resources available to students and teachers in the state.

The department shall establish standards for consortium resources.

House Bill 114

The consortium shall create and maintain a database of virtual education courses for students, training in virtual instruction for teachers, and professional development courses for teachers of students throughout the state if the coursework curriculum meets the state standards established by the department.

The database must be accessible to all school districts that participate in the consortium.

Consortium Membership

Proposed Regulation

9 Member Governing Board

(2) Two tribal representatives

(2) Two members of Statewide Education Agencies

(5) Five individuals employed by school districts, to include:

(A) Teachers and administrators

(B) Representatives from both rural and urban districts

DEED Goals for Distance Learning

1. Create a **sustainable** resource for teachers to share and find high-quality content and courses.

2. Support educators as they learn and demonstrate **effective** distance learning pedagogy.

3. Partner with districts to align resources with **local needs**.

Consortium Concept

- Schools may opt into the system depending on need:
 - Could join at any time
 - What the consortium is would be defined by an oversight group made up of consortium participants and other relevant stakeholders.

Consortium Concept

- Model would provide a structure for sharing costs
 - Cost agreed upon by *consortium governing board*
 - Set into regulation for consistency
 - Not structured by DEED
 - Could result in districts buying seats in classes
 - Could be synchronous or asynchronous

Consortium Concept

- Would provide a framework that ensures BSA and student count data would not be impacted
- Would provide pre-created agreements for interested districts to ease administrative burden

Consortium Concept

- Vetted content
- The model will be refined over the coming year.

It is an opportunity for districts to share resources

What the consortium is not...



It is not a virtual school



It is not a Learning Management System (LMS) – *e.g. Canvas, Moodle, etc.*



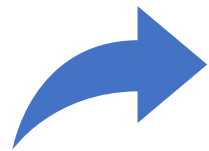
It does not provide a method of counting students



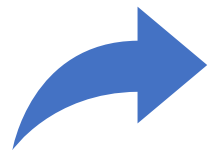
It does not provide teachers

Regulation Timeline

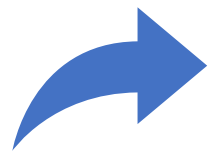
Round One Regulations



April 2023: Proposed Regulations submitted to State Board of Education for review and public comment



June 2023: Finalized Regulations approved by State Board of Education



July 2023: Governing Board recruited by DEED

Round Two Regulations



Governing Board further defines purpose of Consortium



DEED develops regulations to support Consortium vision and purpose



December 2023: Proposed Regulations submitted to State Board of Education for review and public comment



January/February 2024: Finalized Regulations approved by State Board of Education



July 2024: Consortium content begin publication on platform

Next Steps

- Needs sensing (survey)
- Form consortium governing board (pending regulation approval)
- Build a database for sharing resources
- Develop standards for teachers and materials/activities
 - Build a course for teaching online pedagogy
- Provide support and professional learning for capacity building of educators

Distance Learning Survey

Highlights of Current District Response Data:

- 50% provide synchronous at-distance courses to students within their district.
- 12% have students taking courses from teachers in another Alaskan school district.
- 70% have students taking courses from non-Alaskan-district sources (eg: FLVS, BYU).
- 89% of respondents said that teacher training is the primary support their district/school needs to expand their provision of at-distance coursework.
- 82% asked for resources in Google Doc/Sheets they can include in existing courses/units/lessons. 8% asked for full SCORM-importable courses.

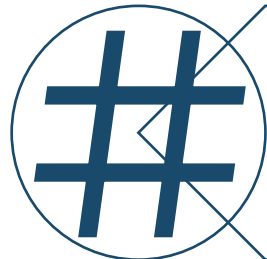
